1 Pending before this Court is a Joint Stipulation to Continue Deadline for
2 Defendants’ Motion to Compel Arbitration, and for Status Conference (“Joint
3 Stipulation”) filed by Defendants Ticketmaster L.L.C. and Live Nation
4 Entertainment, Inc. (together, “Defendants”) and Plaintiffs Julie Barfuss, et al.
5 (together, “Plaintiffs”). Upon consideration of the parties’ Joint Stipulation, and
6 good cause appearing, IT IS HEREBY ORDERED that the Joint Stipulation is
7 GRANTED. The Court orders as follows:

- 8 a. The parties shall submit separate, simultaneous cross-
9 submissions setting forth their respective positions at 5:00 p.m.
10 on October 23, 2023;
- 11 b. The parties may file separate, simultaneous responses to the
12 cross-submissions at 5:00 p.m. on October 30, 2023;
- 13 c. The Court shall hold a status conference on November 6, 2023,
14 at 8:30 a.m.;
- 15 d. Subject to any other orders the Court may issue in connection
16 with any status conference or this joint request, the deadline for
17 Defendants’ motion to compel arbitration shall be extended to
18 November 20, 2023, or two weeks after the date of the status
19 conference, whichever is later.
